## Service Announces Public Scoping Meetings for the Proposed Southern Edwards Plateau Regional Habitat Conservation Plan

The U.S. Fish and Wildlife Service (Service) is announcing the schedule of public scoping meetings for the proposed Southern Edwards Plateau Regional Habitat Conservation Plan and the Service's preparation of a draft Environmental Impact Statement (EIS).

On April 27, 2011, the Service published in the Federal Register a Notice of Intent (NOI) to begin drafting an Environmental Impact Statement (EIS) to evaluate the proposed issuance of an incidental take permit for the Southern Edwards Plateau draft Regional Habitat Conservation Plan (dRHCP).

Led by the City of San Antonio, TX, and Bexar County, TX, the Southern Edwards Plateau Regional Habitat Conservation Plan is an effort to address the potential impacts of infrastructure and commercial and residential development and seeks incidental take authorization for 11 federally-listed species: the golden-cheeked warbler, black-capped vireo, and nine Bexar County karst invertebrates. The proposed planning area covers Bexar County, TX, and six surrounding counties.
